12. General:-

- a) 80th foundation day of UPSC was celebrated on 03.10.2006. Hon'ble Chairman and Hon'ble Members of the Commission graced the function, which was followed by a colourful cultural programme presented by talents available among staff members of the Commission.
- b) A Training Programme on legal matters was organised from 11.10.2006 to 14.10.2006 at Indian Law Institute, New Delhi, which was attended by 19 officers of UPSC. Training Programme covered topics like Indian Law system – Role of UPSC, Constitutional Provisions, Administrative Tribunals Act, Preparation of pleadings/ counter, Supreme Court Rules, Right to Information Act, etc.
- c) A four day Hindi Workshop on official language policy of the Union was organized for Assistants and UDCs during 26-29 September 2006 in the Commission's office, in which, 18 officials participated.
- d) The Meeting of ' Evaluation Committee' was held on 28th August 2006 under the chairmanship of Secretary, in which awards were decided for the Officers/ employees and Sections who performed their official work in Hindi in the various existing incentive schemes in the Commission.
- e) Two officials of UPSC, Sh. Manoj Kumar, LDC and Mrs Anju Mohan, Steno have secured 5th position in All India merit list in Hindi Typing and Hindi Stenography test respectively, which was held in the month of July, 2006 under Hindi Teaching Scheme, Department of Official Language.
- f) "Hindi Fortnight/ Hindi Divas" was celebrated in the Commission's office during 1-14 September 2006. During this period, various competitions for promotion of Hindi were organized. On the occasion of "Hindi Divas" on 14th September, main function was held in a magnificent way under the chairmanship of Shri Gurbachan Jagat, Hon'ble Chairman, UPSC. Prizes /Certificates were given by the Hon'ble Chairman to 74 winners who participated in various competitions held during the fortnight.
