**INDIAN ECONOMIC SERVICE / INDIAN STATISTICAL SERVICE EXAMINATION, 2018**

Based on the result of the Indian Economic Service/Indian Statistical Service written examination 2018 held by the UNION PUBLIC SERVICE COMMISSION in June & July 2018 followed by interviews for Personality Test held in November 2018, the following are the lists, in order of merit, of candidates who have been recommended for appointment to posts in Indian Economic Service and Indian Statistical Service.
