- (a) The scrutiny of the documents/certificates uploaded with online recruitment application was carried out and the details were initially uploaded on the Commission's website on 02 June 2022.
- (b) The candidates were given a widow to express their concerns through email by 20 June 2022.
- (c) **Total 03 (Three) (Roll No 07, 26 & 30)** representations have been received and all of them have been examined.
 - (i) The representations of Roll No 07 & 26 are re-examined. As the experience is from private Hospital and recognition has not been confirmed by Ministry. Enlistment ART Clinics and NABH Certified Entry Level SHCO has been verified from the website, However, the enrollment Number is not the certificate of quality for services provided by the ART Clinic and ART Clinics has not yet been verified by the Experts Committee of the ICMR. The process of verification by the ICMR Experts Committee is in process currently, hence rejection maintained.
 - (ii) The status of Roll No 30 as the experience is from private Hospital and recognition has not been confirmed by Ministry, hence rejection maintained.
- **Modalities**
- (a) Scrutiny has been done on the basis of the scrutiny Report generated by the Computer system as per information filled in by the candidates in the online application form and the documents/certificate uploaded with ORA.
- (b) Candidates with experience in private hospitals have not been shortlisted as it cannot be established that the hospital concerned is a Govt recognized hospital.
- (c) Experience acquired as Part time/hourly basis/daily wages/visiting/Guest faculty/Apprentice/ trainee/consultant/Honorary /Self-employed and stipendiary has not been counted while counting experience. Experience on contract basis in the relevant field has been considered.
