- A total of 02 representations have been received and both the representations alongwith their online recruitment applications with reference to age, category, qualification, experience and desirable experience claimed in the Online Recruitment Application have been examined and none has been found eligible in view of the adopted shortlisting criteria and modalities approved by the Commission.
