(B) EXPERIENCE: Minimum 10 years work experience in commodity/ services level export promotion/ overseas marketing strategy formulation and implementation work.

Modalities:

Modalities adopted for scrutinizing the applications are specified as under:

(i) Scrutiny has been done online on the basis of the report generated by the computer system through Scrutiny of the information filled up/claims made by the candidates in their Online Application.
