Master's Degree in Business Administration or Economics or Foreign Trade or Commerce or Business Economics or Operations Research /Quantitative Methods/ Statistics from a recognized University or Institute.

(B) EXPERIENCE: Minimum 10 years' experience in any of the field of operations research modelling / simulation work for logistics optimization, including in aspects like infrastructure / transport mix optimization, seamless multi-modal network development with integrated procedural and approvals mechanisms and monitoring instrumentation, Supply Chain Management and related strategy development implementation.

Modalities:

Modalities adopted for scrutinizing the applications are specified as under:

(i) Scrutiny has been done online on the basis of the report generated by the computer system through Scrutiny of the information filled up/claims made by the candidates in their Online Application. Supporting documents of only those applicants have been examined which have been found eligible on the basis of claims made in the application.

(ii) Total experience of the candidate as claimed in the Online Application has been taken into consideration, if supported by necessary certificates.

(iii) Only the experience possessed in the relevant fields specified in the advertisement has been taken into account.

(iv) If experience is not in the relevant field as specified in requisition and advertisement of the post or the calculated relevant experience is less than the essential period as specified in the requisition, such candidates have been rejected under “LEQ-B”.
