OBC Candidates having Community Certificate of Backward Classes have been considered Eligible irrespective of date of issuance of such certificate provided the same has not been issued after closing date of the application for the extant post and undertaking for person belonging to non-creamy layer. The same will be collected at the time of Interview. As per the advertisement, Reservation under OBC category will be provided only to those candidates who submit OBC certificates issued by Govt. of NCT of Delhi. Candidates who submit OBC certificate issued by other States/UTs will be considered as General/Unreserved candidates against General/Unreserved vacancies, if they fulfill other criteria.</li><li>ii. Community Certificate issued after closing date of the application for the extant post have not been considered.</li><li>iii. The Birth Certificate has not been considered as valid proof of date of birth.</li><li>iv. Experience as Law Clerk/Research Associate has not been considered relevant.</li><li>v. Experience Certificate issued by Private Law firms/ Judicial Officers indicating experience at Bar has also been considered valid.</li></ol>

**B. The Hon'ble High Court of Delhi, vide order dated 03.09.2021 in WP no. 9539/2021 and other connected matters had directed to the Commission to allow the 36 petitioners who had claimed age relaxation vide court orders to appear in the examination qua the subject post i.e. Assistant Public Prosecutor albeit, on provisional basis, subject to final outcome in the writ petition. Out of the 36 candidates, 12 Candidates were declared qualified After preliminary scrutiny of these 12 candidates, it was found that 3 candidates mentioned below were not able to produce the OBC certificate issued by the Govt. of NCT of Delhi, so they had to be considered as General candidates only. Even though they were over aged as per the criteria of General category, in view of the directions of the Hon'ble High Court of Delhi, these 3 candidates were considered under General Category only. However these 3 candidates did not qualify on General standards.**
