ESSENTIAL QUALIFICATIONS:

(A) EDUCATIONAL:

- (i) MBBS Degree
- (ii) Post-Graduate degree in the concerned speciality or super speciality from a recognised institute.

(B) EXPERIENCE: At least three years' teaching experience as Senior Resident or Tutor or Demonstrator or Registrar or Assistant Professor or Lecturer in the concerned Specialty or Super Specialty in a recognized teaching institution after obtaining the first Post Graduate degree.

The total numbers of effective applications is 159. All the applications have been considered.

1. The scrutiny and short-listing details of this recruitment case were initially uploaded on the website of the Commission on 05/04/2022.

2. The candidates were given a window to express their concerns through email .

3. A total of 14 representations have been received and all of

them have been examined.

4. 03 candidates (Roll No. 120, 125 & 158) have represented against their rejection under LEQ-B(Lacking Essential Experience) category. Their representations along with their application dossiers have been examined and it is observed that:

- After re-examining the application dossier of Roll No. 125 , it is found that she meets the criteria of essential teaching experience of 03 year duration and thus is shortlisted.
- The experience certificates along with the claims made in the online application of the remaining 02 candidates(Roll no. (120 & 158) do not establish the essential teaching experience criteria and hence their rejection under LEQ-B is maintained.

5. 10 candidates (Roll Nos. 04, 07, 10, 17, 26, 49, 53, 84, 90 & 91) have represented against their rejection under LEC (Lacking Enhanced Essential Experience i.e. 3.5 yrs) category. Their representations along with their application dossiers have been examined and it is observed that their experience certificates along with the claims made in the online application of all these candidates do not establish the enhanced essential teaching experience criteria and hence their rejection under LEC(Lacking Enhanced Criteria) is maintained.

6. one candidate (Roll Nos. 104) has represented against her rejection under “Incomplete application due to non submission of deficient documents in response to our Email”. Her representation was examined and it has been found that she did not submit the OBC certificate that was asked from her via Email. Further, she does not fulfil the Enhanced essential experience criteria thereby not fulfilling the criteria to be considered as UR category candidate. Hence, her rejection under “Incomplete application due to non submission of deficient documents in response to our Email” is maintained.

Accordingly scrutiny details have been revised as under:

The following criteria has been adopted for shortlisting of the candidates:

EQ(A) +EQ(B) enhanced to 3 years 6 months for UR candidates
EQ(A) +EQ(B) for all the remaining categories
