OF NCT OF DELHI VIDE ADVERTISEMENT NO. 02/2021 (ITEM NO. 11, VACANCY NO. 21010211223 PUBLISHED ON 23.01.2021). THE COMMISSION CONDUCTED A COMBINED RECRUITMENT TEST ON 19.09.2021.

ON THE BASIS OF RECRUITMENT TEST, COMMISSION HAD INITIALLY SHORTLISTED 274 CANDIDATES FOR THE ABOVE POST DATED 04.01.2022.

ON SCRUTINY OF CERTIFICATES, SUFFICIENT NUMBER OF ELIGIBLE CANDIDATES ARE NOT FOUND FIT TO BE CALLED FOR INTERVIEW. CONSEQUENTLY, THE COMMISSION HAS NOW FURTHER SHORTLISTED THE FOLLOWING ADDITIONAL CANDIDATES PROVISIONALLY TO ACHIEVE THE REQUIRED PROPORTION BETWEEN THE NUMBER OF CANDIDATES AND THE NUMBER OF POSTS AVAILABLE. ONLY SUCH CANDIDATES WHO SATISFY/FULFILL ALL THE ELIGIBILITY CONDITIONS AS PER RECRUITMENT RULES/ PROVISION OF LAW SHALL BE CALLED FOR INTERVIEW.
